THE FISHERIES AND AQUATIC RESOURCES ACT, No. 2 OF 1996

REGULATIONS made by the Minister of Fisheries and Aquatic Resources Development under Section 61(1) (t) of the Fisheries and Aquatic Resources Act, No. 2 of 1996, for the purpose of implementing conservation and management measures adopted by the Indian Ocean Tuna Commission.

Regulations

1. These regulations may be cited as minimum standards for the citizen of Sri Lanka engaged in fishing operations in foreign flagged fishing boats Regulations No. 0f 2015.

2. Any citizen of Sri Lanka who desires to serve in a foreign flagged fishing vessel which operates within the Exclusive Economic Zone of Sri Lanka, High seas, or within the Exclusive Economic Zone of other coastal states shall :-

- (i) be of not less than 18 years of age;
- (ii) obtain an identity card issued by the Director General of the Department of Fisheries and Aquatic Resources to prove his identity in addition to the National Identity Card issued by the Commissioner General of Registration of Persons;
- (iii) not be employed by a person who has been found to be engaged in illegal, unreported and unregulated fishing under the vessel monitoring systems maintained by the respective state.

3. No recruitement Agency or Institute shall employ and citizen of Sri Lanka on behalf of an employer who has been found to be engaged in illegal, unreported and unregulated fishing under the vessel monitoring system of the respective state.

4. (i) Any person who desires to be employed by a foreign flagged fishing vessel shall make and application for a permit substantially in the form specified in the Schedule I hereto.

(ii) Every permit issued under this regulation shall be substantially in the form specified in Schedule II hereto.

5. The Director-General shall issue a permit only on fulfillment of the requirements specified in the regulation 2 hereof.

6. No person shall serve in any foreign flagged fishing boat unless under the authority of a permit issued by the Director General of Fisheries for that purpose.
