REGULATIONS made by the Minister of Fisheries under Section 61 of the Fisheries and Aquatic Resources Act, No. 2 of 1996.

Regulations

- 1. These regulations may be cited as Fisheries (Imposition of Fees) Regulations, 2021 and shall come into operation on 24.11.2021
- 2. The fees specified in Schedule I hereto shall apply in respect of the types of licences specified therein.
- 3. The fees specified in Schedule II hereto shall apply in respect of activities of fish processing establishments specified therein.
- 4. The fees specified in Schedule III hereto shall apply in respect of registration of establishments specified therein.
- 5. The fees specified in Schedule IV hereto shall apply in respect of activities relating to registration of boat yards and allocation of boat numbers for construction of new fishing vessels specified therein.
- 6. The fees specified in Schedule V hereto shall apply in respect of activities specified therein.
