FISHERIES Development and Management Plan of the Chilaw Lagoon Management Area made under Subsection (4) of Section 31B of the Fisheries and Aquatic Resources Act, No. 2 of 1996

Fisheries Development and Management Plan of the Chilaw Lagoon

The document containing these laws, rules, regulations principles and the implementation methodology has been formulated with a view to maintaining the environmental conditions of the Chilaw Lagoon located in Puttalam District in a sustainable manner thereby ensuring and improving the livelihoods carried out in and around the lagoon.

After the plan is approved and forwarded to the Director General of Fisheries and Aquatic Resources by the Coordinating Committee of Chilaw Lagoon, the Director General having examined the compliance with the matters mentioned in the Act shall forward the same to the Minister of Fisheries for approval. (Section 31B).

Once the plan is approved and published in the Gazette the matters in the plan shall become operative (Subsection 4 of Section 31B)

The Minister shall give effect to the provisions of the plan by making appropriate regulations under Section 61 and by publishing appropriate notifications under Section 34. (Subsection 5 of the Section 31B)

01. Fisheries Management Coordinating Committee of Chliaw Lagoon.

The committee appointed by the Director General of Fisheries and Aquatic Resources under the Section 31A of the Fisheries and Aquatic Resources Act No. 2 of 1996 as amended No. 35 of 2013 designated as the Fisheries Management Coordinating Committee of Chilaw Lagoon hereinafter. (Its composition is shown under Annexure 01)

02. The area in which the Fisheries Development and Management Plan of Chilaw Lagoon is implemented

Chilaw Lagoon waters and the land area belonging to 30 identified Grama Niladhari divisions adjacent thereto belonging to the Divisional Secretariat Divisions of Mahawewa, Madampe, Chilaw and Arachchikattuwa in Puttalam District North Western Province of Sri Lanka (Chilaw Lagoon Management Area published in the Gazette Extraordinary No. 1964/3 and dated 25.04.2016 provisions in Section 31(1) of the Fisheries Management Areas of the Fisheries and Aquatic Resources Act, No. 2 of 1996 as amended No. 35 of 2013 is designated as the Fisheries Management Area of Chilaw Lagoon).

03. Major activities to be implemented with the involvement of the Fisheries Management Coordinating Committee of the Chilaw Lagoon.

To formulate a plan including activities / development proposals that can or should be implemented in the Chilaw Lagoon and around it and to implement the same based on the principles indicated in the plan.

All the members and partner institutions of the Coordinating Committee of the Chilaw Lagoon shall operate their services and provide relevant permissions based in the plan.

04. Principles

The Fisheries Management Coordinating Committee should act according to the following principles and values in decision making on harvesting, use and consumption of the resources of the lagoon ecosystem in order to preserve the biodiversity of the lagoon eco system, wildlife and to meet justice between generations.

- Equitable distribution of resources
- Lawfulness
- Co-ordination/representation
- Transparency
- · Environmental friendliness
- Efficiency and effectiveness
- Accountability
- · Common consensus (irrespective of race/religion/caste/political/professional power)
- Effective response
- Collectivity
- Sustainable use of resources

05. Institutional structure

05.01. Implementation Methodology

1. There are 12 Lagoon Fisheries Management Committees that include lagoon fishermen engaged in the fisheries industry in Chilaw Lagoon. (Fisheries Management Committees had been established and registered for Chilaw Lagoon Management area published in Gazette Extraordinary No. 1772/29 and dated 22.08.2012 by Director General of Fisheries and Aquatic Resources provisions in Sub section 3 of Section 32 of Fisheries and Aquatic Resources Act, No. 2 of 1996).

- 2. The 12 lagoon Fisheris Management Committee shall meet separately once every month on agreed dates.
- 3. Twelve (12) members shall represent in the Chilaw Lagoon Fisheries Management Coordinating Committee with one member representing each Lagoon Fisheries Management Committee who is elected at the 12 Lagoon Fisheries Management Committees.
- 4. The Annual General Meeting of the 12 Lagoon Fisheries Management Committee is held in December every year.
- The Coordinating Committee will be established for Chilaw Lagoon with the representation of 12 Chilaw Lagoon Fisheries Management Committee in accordance with the Fisheries and Aquatic Resources Act, No. 2 of 1996 and the provisions of the Fisheries and Aquatic Resources (Amendment) Act, No. 35 of 2013. Its composition is mentioned under Annexure 01
- 6. The Fisheries Management Coordinating Committee of Chilaw Lagoon shall be held once every 3 months and the District Assistant Director of Fisheries shall function as its Secretary while the Director General of Department of Fisheries and Aquatic Resources and the District Secretary functions as Co-chairmen.
- 7. In the case of an essential requirement, the said Committee can meet even before the prescribed period.
 - 7.1 **Decision making methodology within the institutional structure.**
 - 1. The decision making process in respect of harvesting, use and consumption of the aquatic resources of the lagoon shall be carried out by the Lagoon Fisheries Management Committee and the Fisheries Management Coordinating Committee of Chilaw Lagoon in accordance with the principles and agreements identified in this plan.
 - 2. The Director General of Fisheries and the District Secretary of Puttalam shall function as the Co-Chairman of the Fisheris Management Coordinating Committee of Chilaw Lagoon.
 - 3. Fishing operations in the lagoon shall be monitored by the Lagoon Fisheries Management Committee and/or Fisheries Officers, If there are any unsolvable issues, the same shall be referred to the Fisheries Management Coordinating Committee of Chilaw Lagoon.
 - 4. When submitting proposals of Chilaw Lagoon Fisheries Management Committee to the Fisheries Management Coordinating Committee of Chilaw Lagoon, the proposals to be submitted shall be adopted with majority votes by each Fisheries Management Committee. Then, the members representing the Fisheries Management Coordinating Committee of Chilaw Lagoon shall cause the same to be taken up and decided on at the Fisheries Management Coordinating Committee of Chilaw Lagoon.

- 5. The proposals presented by the Fisheries Management Coordinating Committee of Chilaw Lagoon and the other partners for the decision of the Fisheries Management Coordinating Committee of Chilaw Lagoon shall be taken up at the Fisheries Management Coordinating Committee of Chilaw Lagoon (subject to No. 7.1.1)
- 6. When submitting a development proposal that may effect the lagoon ecosystem to the member institutions or partners of the Chilaw Lagoon Coordinating Committee for seeking permissions and discussions or when implementing such a development plan, necessary approval for the same shall initially be taken from the Fisheries Management Coordinating Committee of Chilaw Lagoon.
 - 6.1 In giving the approval, it should be informed to take an approval of the Central Environmental Authority/Provincial Environmental Authority (Environmental Impact Assessment/Environmental Recommendation) and subsequently, the recommendation of the relevant report shall be submitted to the recommendation of the Technical Committee of the Fisheries Management Coordinating Committee of Chilaw Lagoon.
 - 6.2 The Committee shall appoint a Technical Committee that is only relevant to a specific project from among the members of the Fisheries Management Coordinating Committee of Chilaw Lagoon.
- 7. The Fisheries Management Coordinating Committee of Chilaw Lagoon shall make a development plan referred under heading number 05 for the lagoon and accordingly, the Committee by implementing the same, shall take action to monitor, regulate and review the plan.

06. Conservation of protected natural resources and eco species of the lagoon.

All that plant communities in the mangrove ecosystem including the land strip/lagoon water/fish, birds and other aquatic organisms and the islands within the lagoon will be designated as natural resources belonging to the Chilaw Lagoon.

- 1. Mangroves should not be destroyed in the Lagoon Management Area and Mangroves be replanted as appropriate.
- 2. Waste should be disposed of
 - I. When releasing water to the lagoon from shrimp farms adjacent to the lagoon, the same should not be released to the lagoon without it being stored in residual tanks in the farm for at least two weeks.
 - II. Waste water or solid waste discharged from animal farms, factories, hotels, houses, vessels and institutions should not be disposed of to the management area.
 - III. All living and non living resources other than consumable fish shall be considered research/acquisition/ destruction/filling done without the permission and the approval of the Fisheries Management Coordinating Committee of Chilaw Lagoon and no such activity shall be carried out within the lagoon and protected area.
- 3. Declaration of sensitive areas in the Chilw Lagoon.

The fisheries management coordinating committee of chilaw lagoon may designate sensitive areas of the lagoon from time to time and no any fishing activitiers shall be carried out in these areas

07. The activities that can be and cannot be done and restrictions within the Chilaw Lagoon.

1. Only the fishermen who have obtained membership of each of the 12 Fisheries Management Committee are permitted to engage in fishing industry in the lagoon.

 - 2. Having registered the fishing vessels engaging in fisheries industry and fishing operations in accordance with the fisheries and Aquatic Resources Act, No. 2 of 1996, painted the registration numbers properly and obtained fisheries operations licences, the respective fishing operations shall be carried out.
 - 3. It fishing vessels are used for fishing operations in the lagoon, only non-mechanized fishing vessels can be used for that purpose.
 - 4. Fishing methods in the lagoon.
 - 1. Mesh size of gill nets should not be less than 1 1/2" and the maximum net size that can be set is 10 net pieces with the length of 3000 mesh. Fishing operations can be carried out by means of the nets set in the lagoon (gill nets) from 4 pm to 6 am.
 - 2. The mesh size of middle nets of trammel net laid for shrimp in the lagoon shall be not less than 1/2" and the maximum net size which can be set for shrimp fishing is 20 net pieces with a length of 3000 mesh. Also the mesh size of the triple nets set for catching other fish should not be less than 2 1/2". The maximum size of nets that can be set is about 12 net pieces with a length of 3000 mesh. Trammel nets can be used in the lagoon only from 4 pm to 6 am.
 - 3. Only the members of Pambala, Merawala, Karukkupane Lagoon Management Committees can engage in fishing operations using mangrove brush piles. The circumference of one pen should not exceed 25 fathoms (450 meter) and the number of brush files should be not more than 8.
 - 4. Fishing operations carried out by means of cast nets, lift nets for lagoon crabs, longlines, pole and line can be done at any time of the day.
 - 5. Only members selected by the Aluthwatta Carmel Matha Fisheries Management Committee can carry out fyke net fishing only in the places and on dates assigned by the Committee.
 - 6. Basket cane traps can be set from the mouth of the lagoon to the Muthupanthiya in the Dutch Cannel with some management and when tying a basket cane trap, an empty space of about 3 meters should be left in the middle of the cannel.
 - 7. Also, fishing operations using lift nets for crabs, oyster landing operations, fishing operation by hand outside the mangrove areas can be carried out from the mouth of the Maha (big) lagoon only towards the south of the lagoon starting from Inigodawela, Pahala Olidaluwa Grama Niladhari Division by beating the water with a rod and scaring fish.
 - 8. In addition to the above mentioned operations, no any other fishing operations shall be carried out in the Chilaw Lagoon without the permission of the Fisheries Coordinating Committee of Chilaw Lagoon (not applicable to the experiments of the National Aquatic Research and Development Agency)
 - 9. Aquaculture
 - 1. Pen culture -
 - I. Only the members of the Lagoon Management Committee can carry out pen culture in the lagoon.
 - II. Pen culture can be carried out only after receiving the approval of the Fisheries Coordinating Committee of Chilaw Lagoon on the recommendation of the respective Committee.
 - III. After receiving the approval of the Fisheries Management Coordinating Committee of Chilaw Lagoon, operations licence should be obtained from the National Aquaculture Development Authority of Sri Lanka of this purpose.

- 2. Shrimp/fish culture carried out in ponds -
 - I. Permission will not be given to carry out new shrimp culture in the management area.
 - II. The approval of Fisheries Management Coordinating Committee of Chilaw Lagoon should be obtained to resume shrimp of fish culture at an abandoned site of such culture upon the recommendation of the Lagoon Management Committee in the respective area.
 - III. After receiving this approval, operations licenses should be obtained from the National Aquaculture Development Authority of Sri Lanka for this purpose.

09. Submission of amendments to the Fisheries Development and Management Plan of Chilaw Lagoon

The Fisheries Management Coordinating Committee of Chilaw Lagoon shall follow up the Fisheries Development and Management plan once every 3 years and include the amendments and proposals thereto. Once the amendments and proposals so entered are approved by the Committee, the same shall be presented to the Director General of Fisheries and be entered in the Fisheries Management Regulations of Chilaw Lagoon.

10. Violating the contents introduced in the Fisheries Development and Management Plan of Chilaw Lagoon.

When the contents in this plan related to the Fishing activities and the environment of the lagoon are violated, every partner of the Fisheries Management Coordinating Committee of Chilaw Lagoon shall identify the persons who violate the rules and agreements and then necessary legal action can be taken against them in accordance with the Regulations issued in terms of this Plan and the prescripts received by the relevant partners.


